National Yang Ming Chiao Tung University Rules of Recommending Enterprises to Register for TPEx Go Incubation Board for Startup and Acceleration Firms (GISA)

Approved at the 4th Administrative Meeting of the University for the 2021 Academic Year on December 29, 2021

- 1. The Center of Academia and Industry Collaboration, Office of Research and Development, National Yang Ming Chiao Tung University (hereinafter referred to as the Center) has established these rules in order to assist companies to apply for registration on the TPEx GISA, and to issue a "Letter of Recommendation for GISA" or a "Opinion Letter for A Company with Innovative Creativity".
- 2. The companies applying for registration on the GISA as defined herein refer to companies limited and limited companies (hereinafter referred to as "applicant companies") with innovative and creative ideas, future development potential and sustainable management plans organized under the Company Act of Taiwan.
- 3. Applicant companies shall submit the "GISA Registering Application for the Review of A Company with Innovative Creativity", together with their business plans and financial statements for the past year, and apply for the issuance of the "Letter of Recommendation for GISA" or the "Opinion Letter for A Company with Innovative Creativity" to the Center.
- 4. For the purpose of issuing the "Letter of Recommendation for GISA" or "Opinion Letter for A Company with Innovative Creativity", the Center will set up a review committee to conduct the review based on the principle of written information and meeting review. The review will focus on whether the applicant company's technology, product or business model has innovative and creative ideas, future development potential and feasibility of future development schedule.
- 5. The review committee will be convened by the Director of the Center or his/her proxy and five scholars and experts from inside and outside the University will be invited to participate in the review of innovation and creativity, including one expert member from the financial field. In order for the reviewers to fully understand the creative and innovative ideas, future development potential and sustainable operation plan of the applicant company, the personnel in charge of relevant affairs at the University may attend such meeting based on actual need and must attend the presentation and answer the questions of the reviewers. Based on the written information, presentation and answers prepared by the applicant company, the reviewers must fill out the "Opinion Letter After the Assessment of Innovative Creativity" to express their professional opinions.
- 6. Reviewers participating in the review meeting must sign a "confidentiality agreement". Reviewers who have any relationship with the applicant company shall recuse themselves; if not, the convener may order them to recuse themselves.
- 7. If more than half of the reviewers present agree to the application, the application will be approved and the Center will issue a "Letter of Recommendation for GISA" or a "Opinion Letter for A Company with Innovative Creativity" to the applicant company. If the application is not approved and the applicant company is not satisfied with the result of the review, the applicant company may submit new revised information for review after three months, but is limited to one time.
- 8. These rules shall come into effect after being approved by the Administrative Meeting of the University, and shall be amended in the same manner.
